#### **CSWTO** Rules on the Use and Misuse of Certificates

#### PENALTIES WILL BE IMPOSED IF THESE RULES ARE NOT ADHERED TO.

- a) The certificate indicates that the holder has demonstrated an acceptable level of capability by means of assessment and audit under the rules of the Scheme.
- b) The certificate is only valid:
  - i) for the period indicated overleaf
  - ii) if all fees have been paid
  - iii) if it is on cream paper bearing the CSWTO logo, signed by a TWI Certification official
- c) Neither the certificates, nor the CSWTO logo must be used in a manner that may be considered fraudulent.
- d) All certificated organisations are required to keep a register of complaints made against them within the scope of the certificate of capability. Failure to keep such a register or failure to enter valid complaints in it will be construed as a misuse of the certificate and appropriate penalties will be applied, see below. The register of complaints must be made available to TWI Certification on request.

#### Penalties for the Misuse of Certificates

The penalty for misuse of certificates in all the above cases is invalidation of the certificate. If the misuse was in the public domain, publication of the transgression may also be undertaken. Any misuse which appears to be an infringement of the law will result in the matter being reported to the Police.

#### **CSWTO Guidelines on the Use and Misuse of Certificates**

- a) Photocopies of certificates are not acceptable to CSWTO.
- b) Certificates are valuable documents which should be kept in a safe place.
